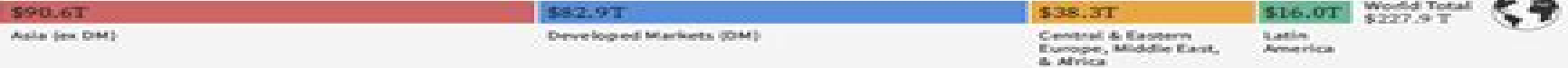


The Global Economy in 2050

Real GDP in 2050 (USD trillions)

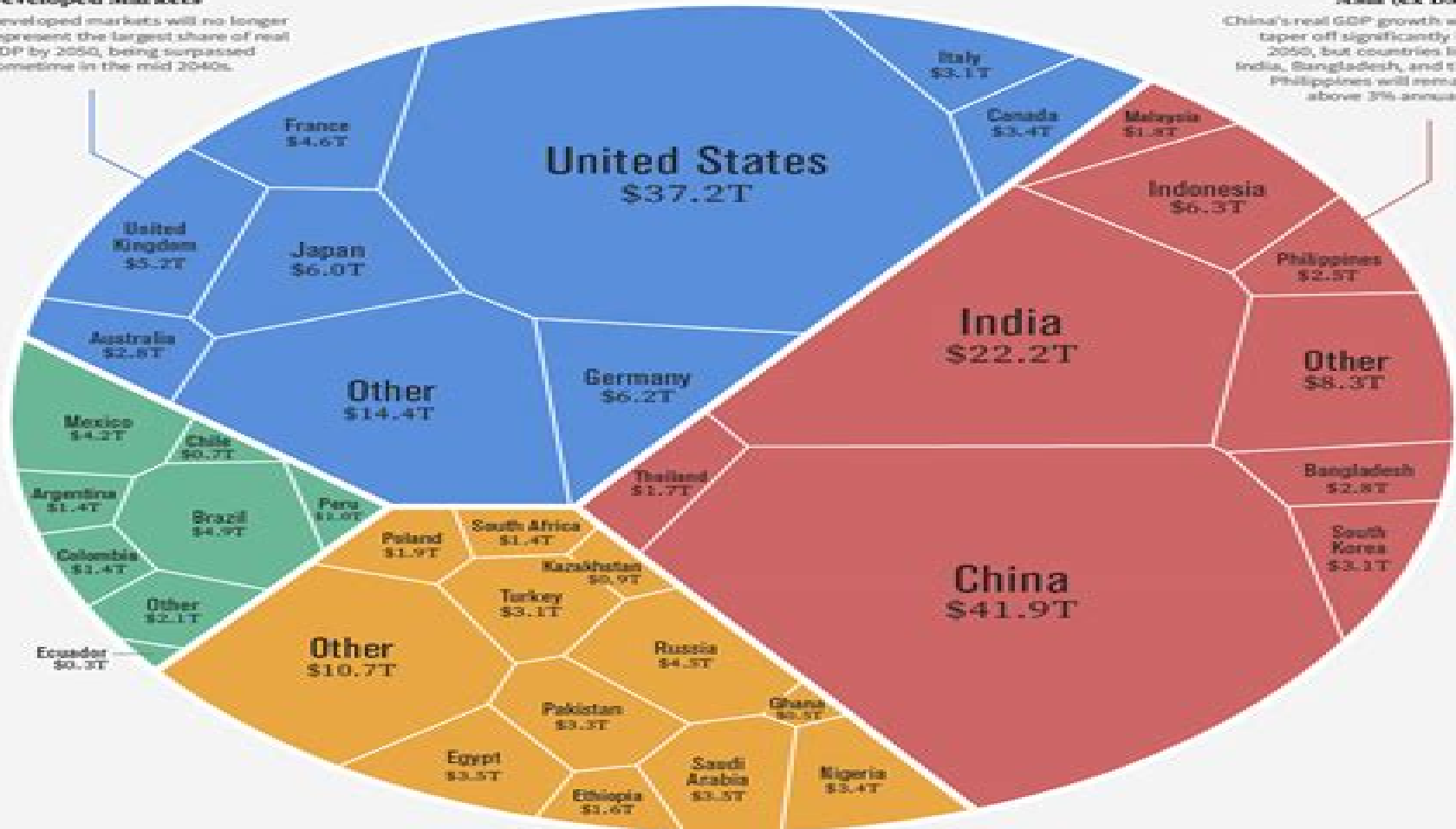


Developed Markets

Developed markets will no longer represent the largest share of real GDP by 2050, being surpassed sometime in the mid 2040s.

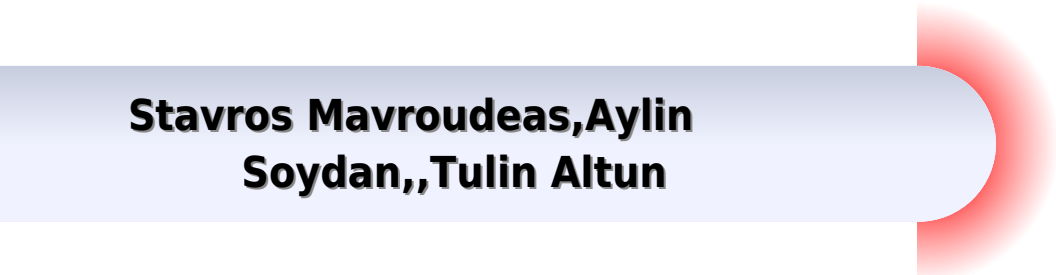
Asia (excl. DM)
