historical source pertaining to the instruction of Nazi medical ethics The 1942 edition sold out within a year and a second edition published in 1943 included an extended appendix of medical laws Through this book Ramm s unique text is now available for an English language audience thanks to the thorough translation and accessible introduction by Melvin Wayne Cooper
