

Art. 2. He shall have power to give to the Congress information of the state of the union, and recommend to them such measures as he shall judge necessary and expedient: In war, he shall command the armies, regulate the land forces, or either of them, and to make appointments thereto, to receive commissions, and subject to the vote of Congress, to pay officers there to such time as he shall please; propose to the Senate appointments and other public business; he shall also have the power to receive ambassadors, and shall execute all the offices of the United States.

Art. 3. The president, vice-president and all civil officers of the United States, shall be removed from office on impeachment for, and conviction of, treason, bribery, or other high crimes and misdemeanors.

## III.

Art. 4. The judges of the United States, shall be elected in one Supreme court, and in such inferior courts as the Congress may from time to time ordain and establish. The judges, both of the Supreme and inferior courts, shall hold their offices during good behavior, and shall, at stated times, receive for their services a salary which shall not be diminished during their continuance in office.

Art. 5. The Congress shall have the power to lay and collect taxes on imports, on the revenue, the loan of money, and on the excise, to regulate commerce with foreign nations, among the several States, and with the Indian Tribes; to establish an uniform rule of naturalization, and uniform rules of bankruptcy; to coin money, to regulate the value thereof, and of foreign coins; to fix the standard of weights and measures; to define offenses against the laws of the United States, to punish the same, to declare war, to grant letters of marque and reprisal, to make rules concerning captures on land and water; to exercise exclusive jurisdiction over all territory belonging to the United States, to make and enforce all laws which shall be necessary and proper to carry into execution the foregoing powers, and all other powers vested by this Constitution in the Government of the United States, or in any department or officer thereof.

WE, the People of the United States, in order to form a more perfect union, establish justice, insure domestic tranquillity, provide for the common defense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ordain and establish this Constitution for the United States of America.

## ARTICLE I.

Art. 1. ALL legislative powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

Art. 2. The House of Representatives shall be composed of members chosen every second year by the people of the several States, and the number in each State shall have no greater or smaller ratio than the representation therein in the first Congress.

The number of Representatives shall not exceed one for every thirty thousand persons; but each State shall have at least one Representative, and the electors in each State shall have the qualification of electors in the most populous State.

The House shall be the origin of all bills for raising revenue, and all bills for appropriating money shall originate in the House, but the Senate may propose or concur with amendments as on other bills.

The House shall have the sole power of impeachment, and the Senate shall have the sole power to try all impeachments, and to decide on the guilt or innocence of the accused, and to vote on the sentence, which shall not extend further than removal from office, and disqualification to hold any office of honor, trust, or profit, during the term of years for which he was elected, or to which he was appointed.
