RELATIONAL DIALECTICS THEORY

Relational dialectics theory explains human interactions. The 4 key features of RDT are: contradiction, totality process and praxis. Below are the 4 key assumptions.

CONTRADICTION

Relationships are always in 'contradiction' because they have inbuilt tensions.

TOTALITY

The theory believes that you should look at the 'totality' of the contradictions in a relationship to see the challenges that exist and how to address them.

PROCESS

Relationships also are constantly in a 'process of change' so they never stay the same.

PRAXIS

'Praxis' is a word that explains how we act in a relationship: we can either accept and accommodate the other person's needs, or act out negatively when tensions occur.
