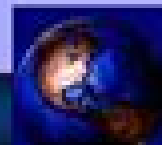

B) Equity carveouts and spinoffs:

- ◆ Carveouts usually followed by spinoffs (eg. DuPont and Conoco, AT&T and Lucent)
- ◆ Mechanism for creating a new company
- ◆ Economic logic:

 - Parent can refocus on its core business
 - Spinoff gives independence to subsidiary and allows management performance to be measured directly
