Chapters 1 & 2 of the TB

Scope and content of property law:

- In wide sense → It deals with "property" all assets that form part of person's estate. Or, it deals with non-legal terminology, a person's "possessions"
 - Includes immovable assets, like a house
 - Movable assets, like a motor car
 - Immaterial property, like a patent
- Remember, private law concerns itself with legal relationships and transactions between private subjects operating on a more / less equal footing
- Public law also plays a part in LPRO > section 25 of the C provides protection for rights in property.
 LPRO must take note of C principles & their effect
- As result of developments, it became impossible to restrict LPRO to corporeal assets / things
 - "LPRO" = more appropriate than "law of things"
- Apart from rights in property, LPRO traditionally deals with relationships that don't qualify as rights at all
 - They are still NB for LPRO because of their legal implications
 - Relationships are described as unlawful control of property, to which the person in question has no right

Apartheid effects -> discriminatory laws must be abolished

 Section 39(2) of C → common + customary law must be interpreted + applied with due regard to spirit & objectives of C

Sources of modern property law:

- RD common law.
 - Must now be applied with greater care & circumspection in every case
 - Must now consider whether it will promote / frustrate the ideals of human dignity, freedom and equality set out in C
- Statutory law:
 - Apartheid was seen to be promoted through legislation (Prevention of Illegal Squatting Act of 1951)
 - New leg have to be evaluated against C backdrop
