- A binary relation R on A is symmetric iff $R = R^{-1}$, that is, if $(a,b) \in R \leftrightarrow (b,a) \in R$.
 - E.g., $=$ (equality) is symmetric. $<$ is not.
 - “is married to” is symmetric, “likes” is not.
- A binary relation R is *antisymmetric* if $(a,b) \in R \rightarrow (b,a) \notin R$.
 - $<$ is antisymmetric, “likes” is not.
