- Please include a detailed description of any people /vehicles observed. Notable observations
  to include are: Height, clothing, male or female, # of people involved, and license plate
  number/description of vehicle.
- 4. All sections of the Witness Statement are to be completed in full.
- Please only include only what you observed, and not what others have told you. If there are other witnesses, each person must complete this form.
- Please initial at the end of your statement and put a diagonal line through any extra space left blank.

You will be required to attend court to present this statement as evidence. If you are not willing to attend, please contact an Enforcement Supervisor at 905-458-3424 x63230.
