They did not mean the pursuit of money or self-indulgent pleasures, much less did they claim a right of seeking enjoyment in various vices or iniquity.

instead, the founders used the term "Happiness" in the classical sense of *eudaimonia*, meaning to lead a good and virtuous life, from Greek and Roman philosophy and later expanded upon by Christian thinkers like St. Augustine and Thomas Aquinas, who taught that the happy life is the blessed life found in God, who is Truth and Love.
