But there is also substantial evidence to prove some of the poorer nations exercise some degree of autonomy. This makes it more difficult to explain cultural imperialism simply as a relationship where developed and developing nations are arranged in dominant subordinate or top down order. Through a strategy of original intent we are able to show the elite in various societies acquire television mainly to satisfy their political economic or social interest. Media attitudes therefore are largely the ideological expression of local elite who determines foreign policy.
