sociological mutual advantage lies at the heart of liberal constitutionalism when it works to produce stable government The book argues that liberalism constitutionalism and democracy are co ordination theories They work only in societies in which co ordination of the important power groups for mutual advantage is feasible It then goes on to examine and interpret the US constitution as motivated centrally by the concern with creating a government to enable commerce In addition the book addresses the nature of the problems that the newly democratic newly market oriented states face The analysis of constitutionalism is based on its workability not on its intrinsic normative or universal appeals Hardin argues similarly there are harsh limits on the possibilities of democracy In general democracy works only on the margins of great issues Indeed it is inherently a device for regulating marginal political conflicts

technical economic information as inputs to improve the performance of impartial benevolent and omniscient governments in their attempts to promote the public interest This indeed was the dominant view within an economics profession that had become besotted by the economics of John Maynard Keynes and Paul Samuelson immediately following the end of the Second World War
