Work rules:

You must follow these work rules to get SNAP benefits.

- 1. Apply to all future foodbanks or work programs.
- 2. Follow the job or work center program rules.
- 3. Accept jobs if you are offered one.
- 4. Continue go to any program without interruption. If you cannot if you have a good reason, call the Texas Health and Human Services Commission (THHS) for advice. Call toll free 1-877-673-6737. Ask for the office you speak Spanish, press 55.

If you don't follow the work rules:

The penalties are:

- 1. First time, no SNAP benefits for one month and interruption of future rules.
- 2. Second time, reduced benefits for three months and further penal follow the rules.
- 3. Third time, no SNAP benefits for six months and further penal follow the rules.

Positive employment when the rules are followed again.

Your rights and responsibilities:

- 1. You do not have to leave (quit) if payments are discontinued, or if the work program satisfies a need why you cannot stay for you.
- 2. You can appeal a determination about your case.
- 3. If you move, telephone or work program, call THHS your new address.
- 4. THHS will show amount money you get from a job or work program changes.
- 5. THHS will show you go to work center work program.
- 6. Call THHS home type work center work rules.

NOTE: THHS found that a person is given educational did not follow the SNAP work rules. By signing this form, the person agrees to follow the SNAP work rules.
