

# Computable General Equilibrium Models for Trade Policy Analysis in Developing Countries: A Survey

Jaime de Melo, *Trade Policy Division, Country Economics Department, The World Bank*

This paper surveys the contributions of computable general equilibrium (CGE) simulation models designed to quantify the implications of alternative trade policy scenarios in developing countries. The paper starts with a review of the basic structure of CGE models, using a one-sector model with product differentiation on the import and export side. The basic properties of CGE models are established and a series of applications to trade policy, internal-external balance and growth, and intertemporal issues are discussed.

## INTRODUCTION

The use of computable general equilibrium (CGE) models for policy analysis has become widespread for both developed and developing economies. For developed economies, with a few notable exceptions, applications have focused on microeconomics with the analysis concentrating on estimating the welfare impact of alternative tax structures or energy policies.<sup>1</sup> In developing countries, CGE models have been used for a wider range of issues, from medium- to long-term macroeconomic policy analysis to the more traditional microeconomic issues analyzed in developed countries as well.<sup>2</sup> Several reasons account for this wider range of applications, particularly the fact that notwithstand-
