#### Definitions

Macro functions - relating to the general role law plays in the running and ordering of society.

Micro functions - derive from those macro functions, relate to more specific uses to which law is put.

#### 2.2 Macro functions of law: law and orders

"The role of law in society - to maintain order."

The problems with this response would be :

- Extremely ambiguous, there is no single concept of order, but rather a variety of orders in relation to which law may play a role including: public order, political order, social order and many others.
- The relationship between law and each of these types of order is extremely complex. The ability of law to shape these different orders is not unconstrained but is subject to wider political and social forces.

The relationship between law and orders in any given society cannot be understood without understanding the political, social, and economic ideologies that underpin that society.

#### 2.2.1 Law and public order

- Many argue that a primary function of law is the preservation of public order. But
  maintaining public order is not exclusively a task for law; many other factors such as
  pressure from family or friends or work colleagues or individuals' philosophical beliefs, play
  an important part.
- The law sets the boundaries of acceptable behaviour and prescribes sanctions for breaches
  of those boundaries.
- The preservation of public order allows people to have the ability to argue freely about their beliefs including going on political marches or joining in demonstrations.
- However limits are set to prevent the use of harmful and threatening language being used to
  insult another person.
