job generation. The decrease in average firm size for the West German economy as a whole can more or less completely be explained by the change in sectoral composition When the employment measure is used no significant shift in the size of firms in the overall US economy between 1976 and 1986 is noticed However when the sales measure is used a slight trend towards smaller firms can be identified By contrast within the manufacturing sector a pronounced shift away from large firms and towards small businesses had occurred This trend is less apparent when the employment measure is used but much stronger when the sales measure is applied Smaller firms have provided the bulk of employment in the Netherlands and there has been a shift towards an increased importance of smaller scale enterprises In Portuguese manufacturing entry barriers namely economies of scale and product differentiation had a negative impact on small firm intensity and small firms avoided export oriented industries that are characterized by more intense competition.
