ELL aware that the opinions and belief of men depend not on their own will, but follow involuntarily the evidence proposed to their minds, that Almighty God hath created the mind free, and manifested his Supreme will that free it shall remain, by making it altogether insusceptible of reffraint: That all attempts to influence it by temporal punishments or burthens, or by civil incapacitations, tend only to beget habits of hypocrify and meanness, and are a departure from the plan of the holy author of our religion, who being Lord both of body and mind, yet classe not to propagate it by correions on either, as was in his Almighty power to do, but to extend it by its influence on reason alone : That the impious prefumption of legiflators and rulers, civil as well as ecclefialtical, who, being themselves but fallible and uninspired men, have affamed dominion over the faith of others, setting up their own opinions and modes of thinking, as the only true and infallible, and as fuch, endeavouring to impose them on others, hash established and maintained fulfe religious over the greatest part of the world, and through all time: That to compet a man to furnish contributions of money for the propagation of opinious which he difbelieves and abhors, is finful and tyrannical: That even the forcing him to support this or that teacher of his own religious persuation, is depriving him of the comfortable liberty of giving his contributions to the particular patter whose morals he would make his pattern, and whose powers he feels most perfusive to right counsels, and is withdrawing from the Ministry those temporal rewards which, proceeding from an approbation of their personal conduct, are an additional incitement to earnest and unremitting labour for the instruction of mankind: That our civil rights have no dependance on our religious opinions, any more than on our opinions in physicks or geometry; That therefore the posteribing any citizen as unworthy the publick confidence, by laying upon him an incapacity of being called to offices of trust and emolument, unless be profess or renounce this or that religious opinion, is depriving him injuriously of those privileges and advantages to which, in common with his feitow citizens be has a natural right: That it tends also to current the principles of that very religious is in meant to accordance, by bribing with a monopoul wordly honours and emoluments, those who will externally models and confidence to its. That it removable honours and emoluments, those who will externally profess and conform to it. That though indeed these are criminal who do not withfland such temptation, yet neither are those innocent who lay the bait in their way. That the opinions of men are not time direct of civil government, nor under its jurisdiction: That to suffer the civil Magistrate to intrude his powers into the field of opinion, and to restrain the profession or propagation of principles on supposition of their ill tendency, is a langerous fallacy, which at once destroys all religious liberty; because he being of course Judge of that tendency will nake his own opinions the rule of judgment, and approve or condemn the fentiments of others only as they thall figure with, or differ from his own. That it is time enough for the rightful purposes of civil government for its officers to interfere when principles break out into overtacts against peace and good order: And finally, that truth is great and will prevail if left to berfelf; that the is the proper and fufficient antagoniff to errour, and has nothing to fear from the conflict, unless by human interpolition, diffarmed of her natural weapons, free argument and debate; errours ceasing to be dangerous when it is permitted freely to

WE the General Affembly of Virginia do enact, that no man fluil be compelled to frequent or support any religious Worthip place or Ministry whatfoever, nor thall be enforced, restrained, molested, or burthened in his body or goods, nor shall otherwife fuffer on account of his religious opinions or belief, but that all men shall be free to profest, and by argument to maintain their opinions in matters of religion, and that the same

finall in no wife diminish, enlarge, or affect their civil capacities.

AND though we well know that this Affembly, elected by the people for the ordinary purposes of legislation only, have no power to refirm the acts of focceeding Affemblies, constituted with powers equal to our own, and that therefore to declare this act irrevocable would be of no effect in law; yet we are free to declare, and do declare, that the rights hereby afferted are of the natural rights of mankind, and that if any ac. shall be hereafter paffed to repeal the prefent, or to narrow its operation, fach act will be an infringement of natural wheelst.
