

TREATY ON FRIENDSHIP, COOPERATION AND MUTUAL ASSISTANCE  
 BETWEEN THE UNION OF SOVIET SOCIALIST REPUBLICS  
 AND THE PEOPLE'S REPUBLIC OF BULGARIA\*  
 [Signed at Sofia, May 12, 1967; entered into force, August 4, 1967]

The Union of Soviet Socialist Republics and the People's Republic of Bulgaria,

Confirming their loyalty to the aims and principles of the Treaty on Friendship, Cooperation and Mutual Assistance between the Union of Soviet Socialist Republics and the People's Republic of Bulgaria of March 18, 1948,

Being deeply convinced that everlasting indestructible friendship, fraternal mutual assistance, and all-round close cooperation between the Union of Soviet Socialist Republics and the People's Republic of Bulgaria, based on the firm principles of socialist internationalism, accord with the fundamental interests of the peoples of both countries and of the entire socialist community,

Noting that cooperation between the Union of Soviet Socialist Republics and the People's Republic of Bulgaria, having reached a much higher stage of development, is characterized by close ties between the key branches of the national economy and the further drawing together of the economy and culture of both countries,

Proceeding from the fact that close economic cooperation between both countries facilitates the deepening of the international socialist division of labor, including that within the framework of the Council for Mutual Economic Assistance,

Desiring to consolidate the fundamental change in the relations between the two countries, which took place both in the course of the joint struggle against the Hitlerite invaders and in the implementation of common aims -- the upbuilding of socialism and communism,

Resolved to incessantly strengthen the unity and solidarity of the countries of the socialist community and unswervingly observe the commitments under the Warsaw Treaty on Friendship, Cooperation and Mutual Assistance of May 14, 1955,

Consistently coming out for the consolidation of peace and security in Europe and throughout the world,

Guided by the aims and principles proclaimed in the Charter of the United Nations,

Taking into account that the Treaty on Friendship, Cooperation and Mutual Assistance, which was concluded in 1948 and which played an historical role in the strengthening of fraternal relations between the Union of Soviet Socialist Republics and the People's Republic of Bulgaria, is in need of a renewal with an eye to the experience and achievements of socialist and communist construction in both countries, development of the political, economic, and cultural coopera-
