There has been some refinement and improvement thanks to the comments made by experts in the field. The chapters in this volume represent second and in some cases even third or fourth versions of the papers. As organizers of the conference and editors of this volume we hope that the reader will be pleased by the content and the high quality of the chapters. There is some diversity but there also are some common themes. We have organized the chapters with respect to what we think are two important themes: 1. behavioral and attitudinal reactions to injustice and 2. macrojustice. These categories are not mutually exclusive for some chapters could have been placed in both categories. Still we think the distinction between these themes has value.

Social Justice In A Diverse Society Tom Tyler, Robert J. Boeckmann, Heather J. Smith, Yuen J. Huo, 2019-07-11 Issues of social justice have been an important part of social psychology since the explosion of psychological research that occurred during and after World War II. At that time psychologists began to move away from earlier theories that paid little attention to people's subjective understanding of the world. As increasing attention was paid to people's thoughts about their social experiences it was discovered that people are strongly affected by their assessments of what is just or fair in their dealings with others. This recognition has led to a broad range of studies exploring what people mean by justice and how it influences their thoughts, feelings, and behaviors.

Current Societal Concerns about Justice Leo Montada, Melvin J. Lerner, 2013-06-29 What role does justice play in the formation of public opinion and the scholarly debates about social problems? Does the perception of injustice force problems to appear on the political agenda? Does the perception of an injustice give momentum to social change? Or are violations of self-interest or threats to one's material welfare the more important factors? Or are empathy-driven concerns for the needy and the disadvantaged motivations to solve societal problems? What is known about the role justice concerns play in leadership? In several chapters of this volume justice concerns and justice motives are viewed in relation to other concerns and motivations: welfare, self-interest, altruism. It is argued that the consensus of political theorists converges on mutual advantage as the main criterion of acceptable solutions to solving societal problems. In economics self-interest is considered the driving force and provides the criterion of acceptable solutions. Sociological and social psychological exchange theories share these basic assumptions. Moreover, in addition to the issue of conflicting motives: self-interest, altruism, justice, it is commonly recognized that the definition of

Values, Achievement, and Justice Norman T. Feather, 2005-12-02 When we say that a person deserves a positive or negative outcome we are making a judgment that is influenced by a number of variables We would certainly take into account whether the person was responsible for the outcome or whether the outcome could be attributed to other sources We would also consider whether the actions that led to the positive or negative outcome were actions that we would value or actions that would meet with our disapproval We might also be influenced by the person's own positive or negative characteristics by our knowledge of what kinds of groups or social categories the person belonged to and by whether we like or dislike the person Information about these different variables has to be considered and integrated in some way and our judgment of deservingness follows that psychological process a process that involves the cognitive affective system Values Achievement and Justice is about deservingness and about the variables that affect the judgments we make I use the term deservingness although I could equally have referred to deservedness or desert The terms are all virtually equivalent in meaning although dictionaries may separate them by using fine distinctions I assume that the sorts of variables I have just described will affect our judgments of deservingness and I further assume that a judgment of deservingness is most likely to occur when these variables fit together in a consistent harmonious and balanced way
