

**The International Energy Relations of China.** By KIM WOODARD. Stanford: Stanford University Press, 1980. xxi, 717 pp. Notes, Bibliography, Index, Tables. \$50.

This work by Kim Woodard of the Resource Systems Institute, East-West Center, Honolulu, represents a nearly encyclopedic survey of China's international energy relations. Woodard divides his work into two sections: "Part I is policy oriented and is entitled 'Energy Policy.' It covers a comparison of Chinese and Western views of the 'energy crisis,' China's substantive international energy policies, and the domestic organizational roots of those policies" (p. 6).

Specifically, chapter 1 attempts to provide an overview of the entire book. Chapter 2 examines Chinese attitudes toward the oil and energy crisis of the last decade; chapters 3 to 9 deal with China's energy policies with respect to the Third World, the Soviet Bloc countries, Western Europe, Japan, the East Asian Continental shelf and offshore development, and international organizations. Chapter 10 places Chinese energy development in a global comparative perspective, and chapter 11 discusses China's major oil field—Tachung. Chapter 12 discusses China's energy future.

"Part 2, the 'Statistical Profile,' is designed to establish a comprehensive set of energy accounts for China from 1949 through the present, and a set of alternative projections to the year 2000" (p. 6). Chapter 13 begins Part 2 and discusses problems of gathering statistics on Chinese energy and methods of analysis. Chapters 14 to 24 provide discussion and analysis of primary energy reserves and resources, alternative estimates of energy production, primary energy production, secondary energy production, aggregate energy consumption, per capita energy consumption, energy trade by commodity and country, total energy trade by commodity, energy plant and equipment imports, and trend analysis and projection methods and alternative energy balance projections. The projections in this volume are based on Dynamo II, a computer program written at the Massachusetts Institute of Technology.

The author's tactic for handling the frequently unreliable statistical reports from the People's Republic of China (PRC) seems to be one of agglomeration. Perhaps these accumulations of figures will puzzle many readers, especially since Woodard frequently fails to distinguish qualitatively between quantitative data.

Woodard's study addresses particularly the international aspects of China's development and energy policies. It is innovative, for it seeks to integrate the "disparate fields of China studies, international relations, and energy development" (p. 6).

I have four major criticisms of this volume. One is the lack of a clear organizational structure despite the author's suggestion that the volume's structure is similar to that of an onion (p. 6). Presumably, as one peels back the chapter layers, the author's message becomes clearer. However, this technique also makes for redundancy. For example, the author devotes a chapter to Sino-Japanese energy relations, but one also finds extensive discussion of this same relationship scattered throughout the volume. The index can only partially relieve the resultant redundancy found in the various chapters and even mirrored at times on the same page. Perhaps more careful editing of the text would have helped.

A second criticism is the author's lack of use of Taiwanese research materials. In the study of the PRC, one of the richest sources of materials comes from Taiwan. (Another source entirely neglected by the author are refugee interviews.) For example, such Taiwan publications as *Issues and Studies* and *Studies in Chinese Communism* have presented important articles on energy.
