

Step 1: Questionnaire, Filling Out Forms

You receive an email notification from the NIH Division of Personnel Security and Access Control (DPSAC) to fill out an investigative questionnaire in eApp. You may be required to provide fingerprints.

Step 2: Submitted Background Investigations

You complete and release the questionnaire to NIH DPSAC. NIH DPSAC will send your questionnaire to DCSA.

Step 3: Conducting the Background Investigation

DCSA receives your questionnaire and starts a background investigation. As part of any investigation, there is a possibility that a DCSA investigator will reach out and contact you for an interview.

Step 4: Position Eligibility Decision Based on Completed Background Investigations

Your completed investigation is sent to NIH DPSAC for a decision and you are notified.

Step 5: Clearance Granting Decision Decision

If needed for your position, a clearance decision is made by NIH DPSAC.

Step 6: Continuous Evaluation/Vetting

If needed for your position, you will be enrolled in a continuous vetting program.
