Further going on to saying that there are variables for OD such as age and type of school whereas TS had no significant variables that contributed to increased or decreased result.

This source describes a study that shows the effects of Effort-Reward Imbalance (ERI) and poor recovery and the overall result in cases of burnout among teachers. "The findings of this study suggest that poor recovery, in terms of low relaxation during leisure time and non-restorative sleep, partially mediates the relationship between ERI and burnout in teachers. In light of our results, it appears that recovery is one of the mechanisms that can help to explain why work stress is associated with burnout" (Gluschkoff 566). The overall result they found is that when combatting ERI with bad recovery off the clock, it shows that there is a significant effect. By giving better recovery times, it can drastically help in preventing burnout overall.
