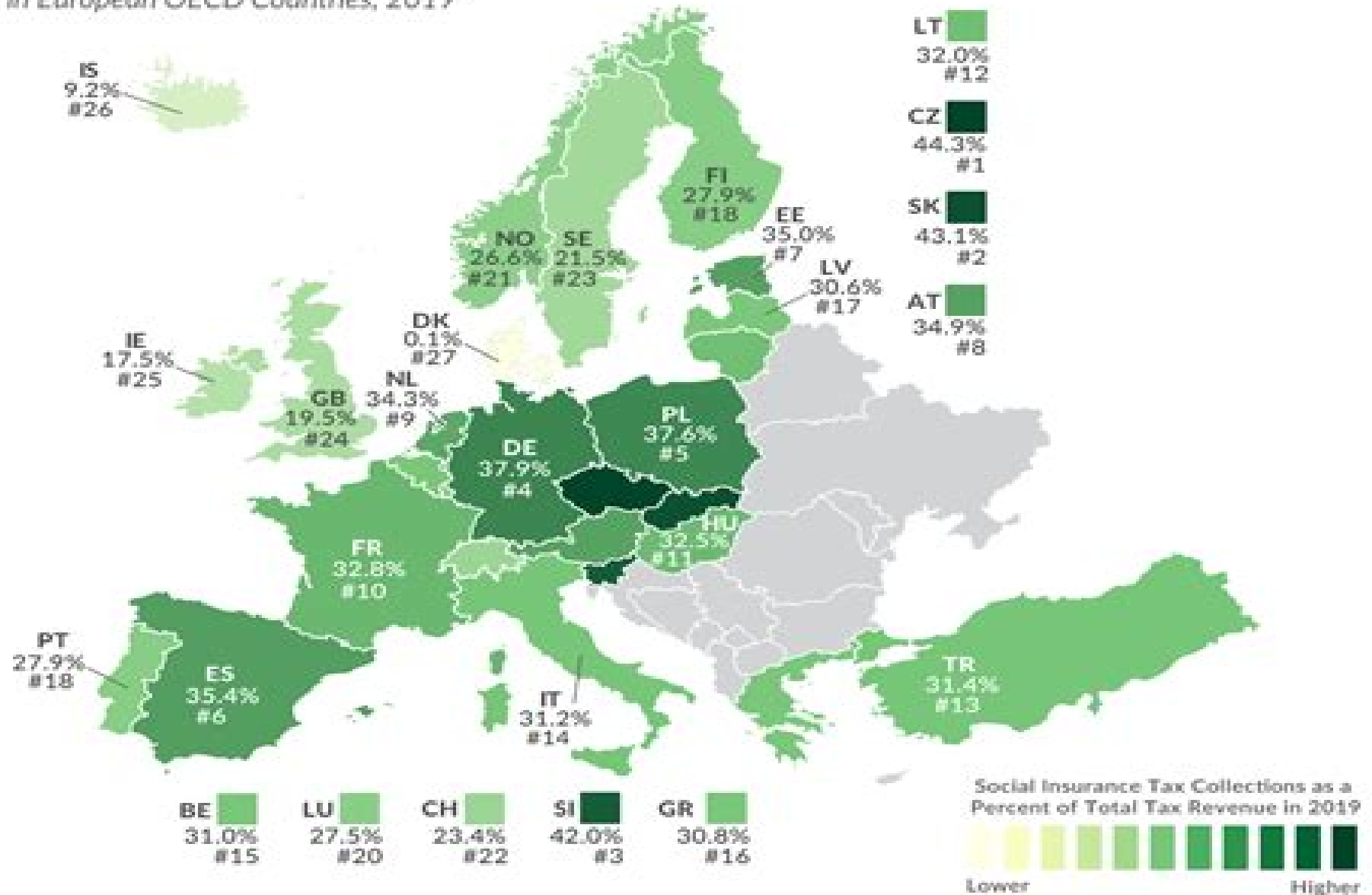


Reliance on Social Insurance Taxes in Europe
