regarded under the law both as moveable property and for the purposes of punishment as moral agents had inevitably a radically different view of Georgia s slave criminal justice system Although the rules and procedures were largely the same for both races the state charged and convicted blacks more frequently and punished them more severely than whites for the same crimes Courts were also more punitive in their judgment and punishment of black defendants when their victims were white a pattern of disparate treatment based on race that persists to this day Informal systems of control in urban households and on rural plantations and farms complemented the formal system and enhanced the power of slaveowners Criminal Injustice shows how the prerogatives of slavery and white racial domination trumped any hope for legal justice for blacks
