Carolina In Ireland his first concern was the recovery of his family s estate in County Meath and the purchases of other nearby properties In England he concentrated his land purchases in Hampshire while investing heavily in the government s wartime debt the stock of the great trading and insurance companies and in private mortgages and bonds Of special interest is the international character of his investments which adds a new dimension to the economic history of the Atlantic region Of particular importance also is his rise in status through wealth from the declining Catholic gentry of Ireland into which he had been born to become MP for the City of Westminster which invariably returned men of the highest social standing His wealth after his early death in 1752 also enabled his daughters to marry into the nobility The effects of the American Revolution and the 1798 Irish uprising hastened the repatriation of his assets to England where his aristocratic heirs were content with a more modest return on Warren's capital which by then exceeded a quarter of a million pounds sterling
