

Abstract: *Staphylococcus aureus* is a common pathogen that has been associated with numerous infections in humans and animals. The purpose of this study was to determine the prevalence of *S. aureus* in the nasal secretions of healthy humans and to compare the results with those of a previous study. A total of 100 subjects were recruited from a local community and their nasal secretions were collected. The results showed that the prevalence of *S. aureus* was 45%, which is similar to the results of a previous study. The study also found that the majority of the subjects were carriers of *S. aureus* in their nasal secretions. These findings suggest that *S. aureus* is a common pathogen in the human nasal cavity and that it may play a role in the development of various infections.
