However he spent a large portion of his wealth to promote a form of gradual democratic socialism in the United States Haynes advocated the transformation of the nation's economy and government yet he campaigned for morality laws that limited personal freedom Haynes s motivation was not social status or money both of which he had before his conversion to social reform Nor was it political power he never ran for office except as a temporary freeholder or created a personal political machine His primary motive was a perhaps arrogant yet honest desire to aid in the creation of a more just society by improving the living and working conditions of the less fortunate In one way or another Haynes participated in all the major social and political events that shaped California and Los Angeles in a most dynamic era of their development In a broader sense Haynes s life serves as a yardstick with which to measure other progressives of his time and as a key for understanding the motivation of those idealists who helped shape our present political institutions Official **Congressional Directory** United States.
