

SIR WILLIAM MARTIN

Tauranga soon became widely known among the Maoris by reason of the hospital which the Martins established on their property and which they maintained throughout their first period of residence in New Zealand, from 1842 to 1856. In 1847 a Government hospital was built in Auckland, with a ward specially set apart for the natives. Nevertheless, they preferred the more homely atmosphere of the ramapo building at Tauranga, where the Judge and Mrs Martin could speak to them in their own language and where discipline was mild. The patients came from all over the northern half of the island and Lady Martin many years afterwards said with pride that the majority of their visitors recovered their health as a result of treatment at Tauranga.

Despite the many extra-judicial tasks undertaken by the Chief Justice, he found time to continue his deep reading. For example, his wife records that in 1861 they had completed during their leisure moments the reading of the works of Tertullian and thereafter became busy on the study of Cyprian. Many years after, writing to Bishop Hadfield, Martin explained the motive underlying his intensive study of matters outside his profession. He said that all the experience of his life had led him to think that the most healthy condition of a man's mind is when he combines the discharge of practical duties with meditation on more abstruse subjects, when the soul has the intervals of rest and refreshment provided for it in its weariness.
