If the Client provides any tools, equipment and materials, they will be used exclusively for the Client's related projects and it will be returned at the conclusion of the work described in this Contract. No subcontractors or consultants shall be engaged to carry out any part of the Services without prior written permission of the Client. The Client shall have the right at any time to request the immediate replacement of the Provider's personnel.
