#### 1. INTRODUCTION

Contract of sale = between buyer + seller

Contract determines which party has to arrange the transport

Contract of carriage = between shipper - carrier - consignee

\* Shipper = party instructing the carrier (can be either seller or buyer)

There is a factual link between the contract (however no legal link)

Shipper/ consignee can have a claim under:

- Both contracts
- Only contract of sale
- Only contract of carriage
- None contract

Type of claim depends on 1. The type of contract 2. Parties position under that contract

Relevance:

- 1. Determines which party has to bear the risk for damage during transport
- 2. Who bears the cost of the transport

Rules applicable: CISG/ INCOTERMS / national law or EU consumer directives CISG

- Article 31 CISG → place of delivery
- Article 32 CISG → Seller's obligations
