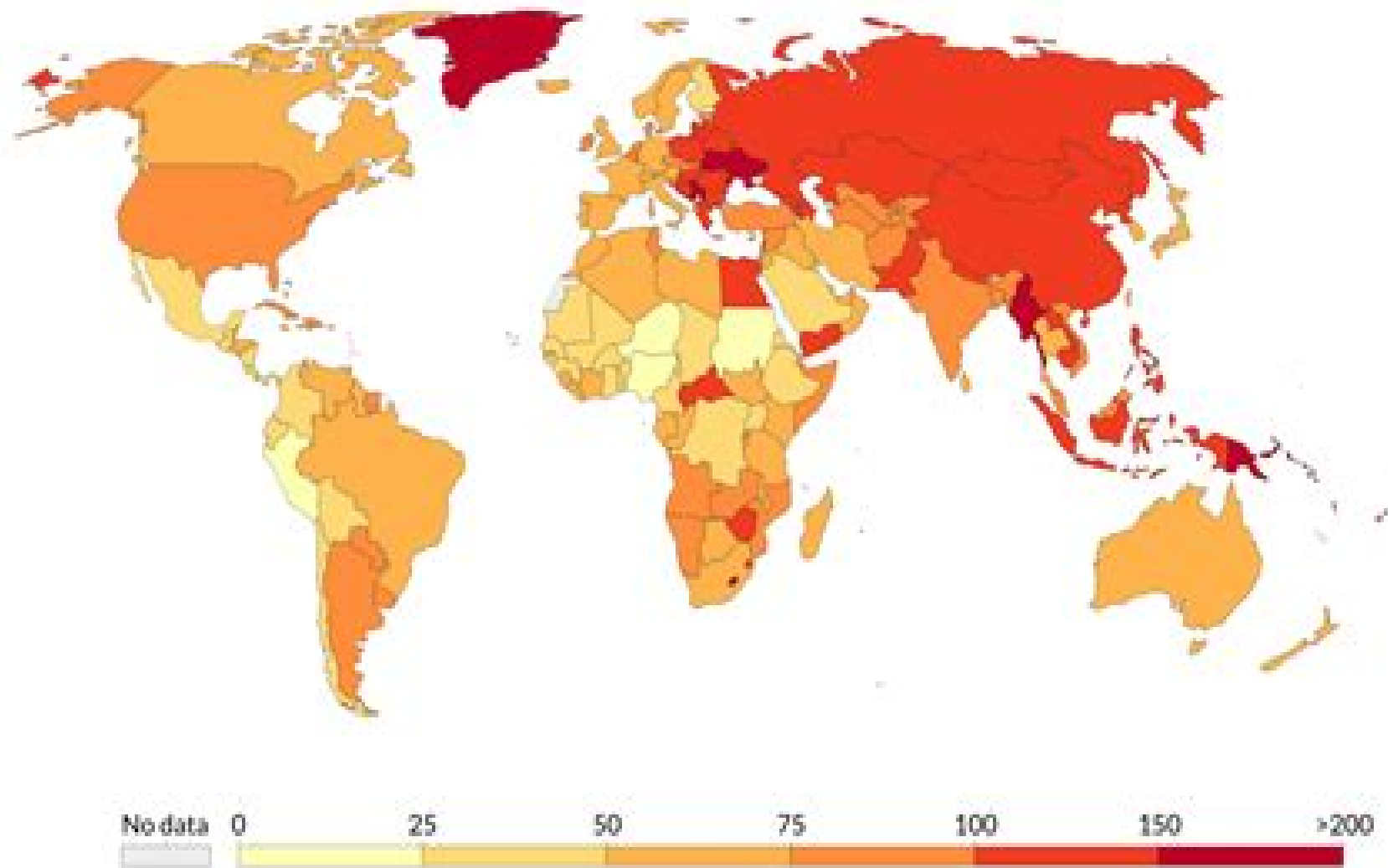


# Death rates from smoking, 2017
