- **The mix, quality, and yield of the loan portfolio are heavily influenced by regulation**
- **Examples of lending regulations:**
 - **The total volume of real estate loans granted by a U.S. national bank cannot exceed that bank's capital and surplus or 70 percent of its total time and savings deposits, whichever is greater**
 - **An unsecured loan to a single customer normally cannot exceed 15 percent of a single national bank's unimpaired capital and surplus account (legal lending limit)**
- **Any loans made are subject to examination and review**
