per employee and it is a major contributor to Swiss export revenues. But this is no cause for complacency. The industry is subject to rapid change as the competitive climate has become rougher nationally and internationally. Major structural weaknesses have come to the surface which raise serious questions about the extent of the required structural adjustments.
