"For we saw Him, even on the right hand of God; and we heard the voice bearing record that He is the Only Begotten of the Father—"

"That by Him, and through Him, and of Him, the worlds are and were created, and the inhabitants thereof; and begotten sons and daughters unto God" (D&C 109:24-26).

We declare in words of eternity that His priesthood and His Church have been restored upon the earth—"Built upon the foundation of . . . apostles and prophets, Jesus Christ himself being the chief corner stone" (Ephesians 2:20).

He will rule as King of Kings and Lord of Lords, and every knee shall bend and every tongue shall speak in worship before Him. Each of us will stand to be judged of Him according to our works and the desires of our hearts.

We bear testimony, as His duly ordained Apostles—that Jesus is the Living Christ, the eternal Son of God. He is the great King Emmanuel, who stands today on the right hand of His Father. He is the Light, the life, and the hope of the world. He was the one that made it possible in the life and opening life in this world to come.
