## **Course Description**

In Texas, injured consumers can seek relief under a variety of statutory and common law sources. The primary focus of this course is the main Texas consumer protection statute: the Texas Deceptive Trade Practices Act (DTPA). We will study who may sue under the DTPA; whom may be sued; what conduct the statute prohibits; what defenses defendants can raise; and what remedies the statute provides. In addition to the DTPA, we will discuss Texas warranty law, Texas and federal debt collection law, Texas tie-in statutes, and overview several related federal consumer laws.

This course will reach beyond substantive Texas consumer law. Many of the cases we will discuss involve courts interpreting the DTPA, so this course provides an opportunity to study how courts interpret statutes. Also, we will discuss some policy issues that arise in formulating optimal consumer protection law.

The objectives of the course are for you to learn the rules and doctrines of Texas Consumer Law; for you to understand the ethical and professional issues that arise in connection with Texas Consumer Law; and for you to be able integrate the information you learn in this class with other practical and analytical skills necessary to the practice of law. Consumer Law is a part of the Texas Bar Exam.
