**14-331. Stalking; essential elements.**

For you to find the defendant guilty of stalking [as charged in Count \_\_\_\_\_]<sup>1</sup>, the state must prove to your satisfaction beyond a reasonable doubt each of the following elements of the crime:

1. The defendant intentionally pursued a pattern of conduct that would cause a reasonable person to feel frightened, intimidated or threatened on more than one occasion by:<sup>2</sup>
