He also helped reconcile the Catholic Church and science by establishing the Pontifical Academy of Sciences and took the first steps to move the Church away from entrenched anti-Semitism. Pius XI continued his predecessor's policy of the indigenisation of the missionary churches in preparation for decolonisation. Pius XII fully

embraced the media and other means of publicity and with his infallible promulgation of the Assumption in 1950 he took papal absolutism and centralism to such heights that he has been called the last real pope Ironically he also prepared the way for the Second Vatican Council
