Framing the Fight against Human Trafficking Amanda D. Clark, 2019-06-04. Nongovernmental organizations (NGOs) in the anti-human trafficking movement have proliferated over the past few decades; many of these NGOs have joined coalitions to pool resources and expertise. How do changes in the external political environment or the internal coalition structure impact NGO framing strategy? *Framing the Fight Against Human Trafficking: Movement Coalitions and Tactical Diffusion* uses a unique dataset to analyze the discursive processes of fifteen U.S. anti-trafficking NGOs involved in the Alliance to End Slavery and Trafficking (ATEST) from 2008–2014.
