Jones, 2013-03-09 in the culture of medicine and they saw their mission as a generation of profit for stockholders not necessarily medical care for clients Cost effective medicine was the goal in the context of a profit making enterprise Although preventive health care programs were promised very few were realized and they were not nearly comprehensive The definition of unnecessary testing slowly expanded to mean virtually any high cost test requiring the service of a medical specialist and low priced generalist physicians with limited diagnostic and therapeutic skills were made available to patients with the instruction they should limit their access to high cost specialists Managed care organizations tended to reward primary care physicians who avoided specialty referrals and severed contracts with those who persisted in sending their patients to outside consultants Most notoriously managed care organizations maintained veto authority over the provision of complex and expensive care and that veto was often wielded in defiance of a physician's recommendation by managed care employees without medical training or experience Managed care did indeed slow the rate in increase of medical costs but not without limitations on the care provided to patients and the professional integrity of physicians Managed care organizations were so successful that they could provide extremely high salaries to their executives even in the context of limiting cost and care It is these developments that the papers of this symposium addressed The most

The morality of capital punishment has been debated for a long time This however has 1 not resulted in the settlement of the question either way Philosophers are still divided In this work I am not addressing the morality of capital punishment per se My question is different but related It is this Whether or not capital punishment is morally right is it moral or immoral for medical doctors to be involved in the practice To deal with this question I start off in Chapter One delineating the sort of involvement the medical associations consider to be morally problematic for medical doctors in capital punishment They make a distinction between what they call 2 medicalisation of and involvement in capital punishment and argue that there is a moral distinction between the two Whilst it is morally acceptable for doctors to be involved in capital punishment according to the medical associations it is immoral to medicalise the practice I clarify this position and show what moral issues arise I then suggest that there should not be a distinction between the two The medical associations argue that the medicalisation of capital punishment especially the use by medical doctors of lethal injection to execute condemned prisoners is immoral and therefore should be prohibited because it involves doctors in doing what is against the aims of medicine

**The Ethics of Animal Experimentation** Donna Yarri, 2005-08-18

The ethical treatment of animals has become an issue of serious moral concern. Many people are challenging long held assumptions about animals and raising questions about their status and treatment. What is the relationship between humans and animals? Do animals have moral standing? Do we have direct or indirect duties to animals? Does human benefit always outweigh animal suffering? The use of animals for experimentation raises all of these questions in a particularly insistent way. *Ethics Demonstrated in Geometrical Order* Latin *Ethica ordine geometrico demonstrata* usually known as the *Ethics* is a philosophical treatise written by Benedict de Spinoza. It was written between 1664 and 1665 and was first published in 1677. The book is perhaps the most ambitious attempt to apply the method of Euclid in philosophy. Spinoza puts forward a small number of definitions and axioms from which he attempts to derive hundreds of propositions and corollaries such as "When the Mind imagines its own lack of power it is saddened by it," "A free man thinks of nothing less than of death," and "The human Mind cannot be absolutely destroyed with the Body, but something of it remains which is eternal." The first part of *The Ethics* addresses the relationship between God and the universe. Tradition held that God exists outside of the universe, created it for a reason, and could have created a different universe if he so chose. Spinoza denies each point. According to Spinoza, God is the natural world. As with many of Spinoza's claims, what this means is a matter of dispute. Spinoza claims that the things that make up the universe, including human beings, are God's modes. This means that we and everything else are in some sense dependent upon God. The nature of this dependence is disputed. Some scholars say that the modes are properties of God in the traditional sense. Others say that modes are effects of God. Either way, the modes are also logically dependent on God's essence. In this sense, everything that happens follows from the nature of God, just like how, as Spinoza puts it, it follows from the nature of a triangle that its angles are equal to two right angles. Since God had to exist with the nature he happens to have, nothing that has happened could have been avoided, and if a particular fate for a

particular mode is fixed by God there is no escaping it or as Spinoza puts it A thing which has been determined by God to produce an effect cannot render itself undetermined God s creation of the universe is not a decision much less one motivated by a purpose The second part of the Ethics focuses on the human mind and body Spinoza attacks several Cartesian positions that the mind and body are distinct substances that can affect one another that we know our minds better than we know our bodies that our senses may be trusted that despite being created by God we can make mistakes namely when we affirm of our own free will an idea that is not clear and distinct
