By guaranteeing a consistent implementation of rights across the Union, these treaties give the European Union the authority to take action against member states that transgress these essential values. Furthermore, these accords established the idea of EU law's primacy, which states that EU law takes precedence over national law in cases of disagreement. This principle is essential
