dueling When judges and juries regularly refused to convict duelists these legislatures created extrajudicial punishments by requiring elected and appointed officials as well as lawyers to swear oaths of non participation in dueling Young men obsessed with honor and reluctant to perjure themselves for fear of damaging their public reputation soon took to carrying Bowie knives and handguns with which to kill those who insulted them a perfectly honorable action to much of the population The state legislatures then severely regulated carrying of concealed deadly weapons in the hope of suppressing the bloody results of what had been until then an accepted practice
