Brine, 1992 Comecon or the Council for Mutual Economic Assistance was founded by Joseph Stalin in 1949 to counteract the Marshall Plan and reinforce the bonds between the Soviet Union and the people's democracies of Eastern Europe Other Soviet Bloc nations later joined Comecon and for forty years it dominated the trade policies of the Soviet Bloc and profoundly influenced their domestic economic development and relations with the West Comecon collapsed in 1991
