security in which security defined as stable strategic deterrence between two states is analysed Finally Chapter 6 analyses the question of what happens to security based on strategic deterrence when states enter into the disarmament process More specifically the role of verification in preserving security in such circumstances is analysed thereby answering the main problem of the book The supporting data for Chapter 6 is given in the Appendix
