Australia and Canada, the other two semi peripheral countries, are examined in the middle. Also included are comparisons with the epicentre of the core base of power, the United States. The individual chapters focus on the effect on specific groups of people, including males and indigenous groups, the mechanisms people use to both cope with dramatic social changes and the strategies and alliances that are used to affect the course of changes. It covers topics that range from implications of labour migration on care regimes to globalism's effect on masculinity and the male breadwinner model.
