excessive surveillance erodes trust between the individual and the Government and can change the nature of the relationship between citizen and state The report sets out a series of ground rules for Government and its agencies to build and preserve trust The Government should make full use of technical means of protecting personal information and preventing unwarranted monitoring of individuals activities But the Government should also carry out rigorous risk analysis of any proposal to establish major new databases or other systems for collecting data take full responsibility for protecting personal information and ensure that its policies and procedures in relation to data collection and storage are as transparent as possible
