chance of conflict relapse in the future whereas the rejection of mediation risks ongoing bloodshed as war continues The trade off between mediation s short term and long term effects is stark when the third party mediator adopts heavy handed forms of leverage and Beardsley finds multiple mediators and intergovernmental organizations also do relatively poorly in securing long term peace He finds that mediation has the greatest opportunity to foster both short term and long term peace when a single third party mediates among belligerents that can afford to wait for a self enforcing arrangement to be reached
