The Companies (Tables A to F) (Amendment) Regulations 1985

<i>Made -</i>	10th July 1985
<i>Laid before Parliament</i>	10th July 1985
<i>Coming into Operation</i>	1st August 1985

The Secretary of State, in exercise of the power conferred by section 8 of the Companies Act 1985^(a), hereby makes the following Regulations—

1. These Regulations may be cited as the Companies (Tables A to F) (Amendment) Regulations 1985 and shall come into operation on 1st August 1985.

2. The regulations in Table A in the Schedule to the Companies (Tables A to F) Regulations 1985^(b) are hereby amended as follows:—

- (a) in regulation 4 by substituting for the word "provision" the word "provisions";
- (b) in regulation 31 by inserting before the words "such time and place as the directors may determine" the word "to";
- (c) in regulation 115 by deleting the words "unless the contrary is proved".
