

Slavery in the Constitution

- South Carolina delegates were the major voice to keep slavery
- 170,000 slaves came to Georgia and SC between 1787 and 1808
- Constitution gave national government no power to interfere with slavery in the states
- 3/5 Compromise gave southern states tremendous political power
- Between 1788 and 1848, 12 of the 16 Presidents were southern slaveholders
