- Soil Conservation Act 1935
 - Authorized formation of Soil Conservation Service, now called Natural Resource Conservation Service (NRCS)
 - Assess soil damage and develop policies to improve soil
- Food Security Act (Farm Bill) 1985
 - Required farmers with highly erodible soil had to change their farming practices
 - Instituted Conservation Reserve Program
 - Pays farmers to stop farming highly erodible land
