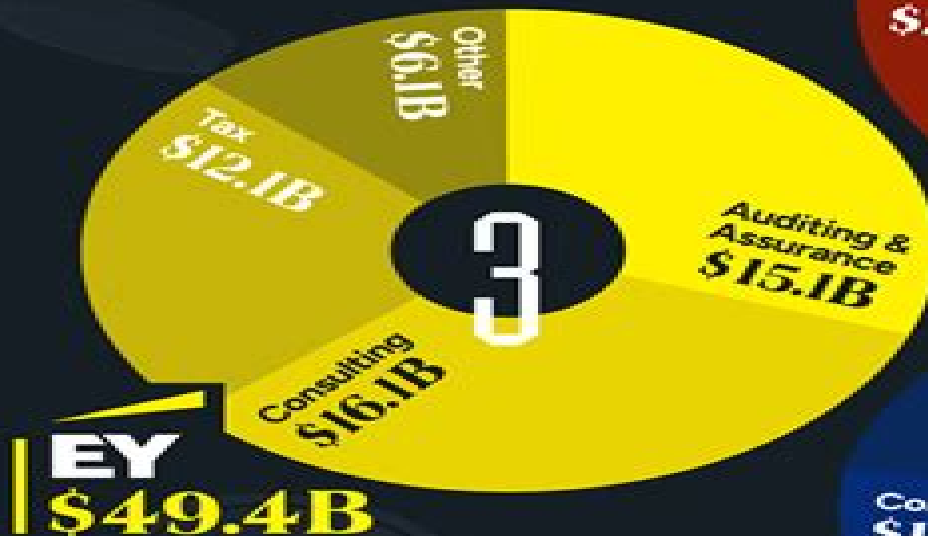
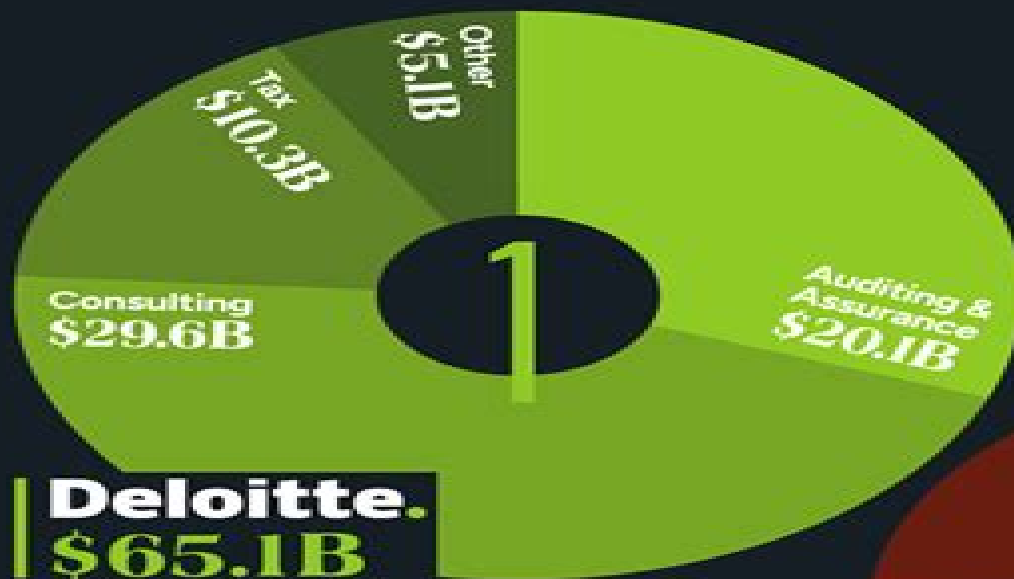


Revenue of the BIG FOUR Accounting Firms
