

# Small and Medium-Sized Enterprises

- United Nations defines as parent companies whose affiliates had assets, sales and net income under \$3 million; fewer than 500 employees
  - SMEs accounted for 96.5% of U.S. exports in 1997
  - Very small companies (less than 20 employees) accounted for 65% of all U.S. exporting firms in 1997
  - Almost 40% of SME exports went to Canada, Japan and Mexico
  - Majority of SMEs exporting were wholesalers or other nonmanufacturing companies
